





Note: Other than Maharashtra State Candidates shall be eligible for institution quota only

### **Eligibility for B. Pharm Course**

- 1) Maharashtra State Candidature Candidates :-
  - The candidate should be an Indian National:
  - Passed HSC or its equivalent examination with Physics and Chemistry as compulsory subjects along with one of the Mathematics or Biology and obtained at least 45% marks (at least 40% marks in case of candidates of backward class categories EWS categories and Persons with Disability belonging only to Maharashtra State) in the above subjects taken together.
  - Should have appeared in all the subjects and should obtain non zero score in MHT-CET conducted by the Competent Authority.

#### 2) All India Candidature Candidates :-

- The candidate should be an Indian National;
- Passed HSC or its equivalent examination with Physics and Chemistry as compulsory subjects along with one of the
  Mathematics or Biology and obtained at least 45% marks (at least 40% marks in case of candidates of backward class
  categories EWS categories and Persons with Disability belonging only to Maharashtra State) in the above subjects taken
  together; should obtain non zero positive score in NEET or the candidate should have appeared in all the subjects in
  MHT-CET and should obtain non zero score in MHT-CET conducted by the Competent Authority. However, preference shall
  be given to the candidate obtaining non zero positive score in NEET over the candidates who obtained non zero score
  in MHT-CET.

- Any other criterion declared from time to time by the appropriate authority as defined under the Act.


### National Service Scheme (NSS) Not Me But You






