Transparent mechanism for timely redressal of student grievances

The college is well versed with mechanism of submission of grievances. The individual student can submit his grievances /complaint through college website by mentioning his basic details.

Online Grievances Mechanism

- Step 1: Link is given on website for submission of grievance
- Step 2: Students can also submit e-grievance through their ERP login
- Step 3: Enter email id and confirm it by entering OTP sent on registered email id.
- Step 4: Enter first name and last name
- Step 5: Select the course
- Step 6: Write title and details of grievance in given field
- Step 7: Enter mobile number and submit the grievance by entering the OTP

Through ERP

Step1: Login through ERP by Members of grievance redressal cell. Read the grievance carefully, discuss with cell and provide solution to the grievance.

The system automatically sends alert to the grievance administrator the complaint is forwarded to the committee. If the grievance is justified by the committee it offers the solution to the student within 2 days.

If the student accepts the solution agreed action is taken. Grievance and action taken is recorded and feedback is taken from the student.

If the student is not satisfied with the solution the case is given to the Principal for review. If the student is still not satisfied with solution the grievance is referred to next level of investigation and grievance is resolved.

Offline Mechanism

The grievance can be lodged in offline mode using the suggestion box which is placed in college office.

The complaint is discussed by the committee and further course of action will be decided and the same shall be intimated to the students.

The redressal committee enquires and analyses the nature and pattern of the grievances in a strictly confidential manner. Emphasis on procedural fairness has been given with a view to "the right to be heard and right to be treated without bias"








Mechanisms for submission of online student's grievances

Topic: "Jijau te Savitri"


Name of Speaker: Adv. Krantitai Gargote
