➤ Plastic free week activity

RJSPM's COP actively coordinates cleanliness activities in the college campus and beyond the campus by organizing different activities like Swachh Bharat Abhiyan, Sawchata hich seva (Cleanliness is service), Swaccha wari-Swasta wari (Clean pilgrimage - healthy pilgrimage) etc. The entry of automobiles inside the campus is restricted to reduce environmental pollution of campus. We encourage our students and staff to use public transportation. Single—use plastic stuffs such as plastic bottles, bags, spoons, straws and cups are banned completely and awareness is created among all teaching, non-teaching staff and students. The NSS and SDO team of our college conducts various programs of cleaning the campus. Landscaping initiatives are best methods to build awareness around the environment. The landscape of trees and plants provide the students and staff with clean and cool air and a soothing environment. We conduct tree plantation activities through NSS team.

We have Medicinal plant garden with well-planned and classified cultivation of medicinal plants. Garden has more than 50 species of medicinally important plants. These plants are particularly used by students for their understanding of practical and theory concepts. Institute has installed sanitary napkin vending and disposal machine, which helps in instant disposal of used napkins in a very scientific and hygienic way without generating harmful emissions. The Municipal Corporation's water supply and bore well are the sources of water supply to the college campus. Our college is aware about the water conservation measures and problems associated with water shortage and therefore we follow the practices for water conservation and efficient use of available water. Water tanks are constructed in campus for proper storage of water. Water is pumped into storage tanks located at different places in the campus. Overhead storage tanks are also available. The water is distributed through pipe network in college campus. Maintenance of water bodies and distribution system is periodically carried out to avoid the loss of water by leakage. Some of the common solid wastes include daily garbage comprising of white used papers, card sheets and materials, rubber waste,

plastics, cardboard materials, etc. These are collected in dustbins placed in the campus and disposed in ecofriendly manner on daily basis. Separate dustbins are kept in campus for dry and wet waste. The glassware waste is collected and disposed properly. For disposal of papers "Recyclers India Shredding Services" an agency in Pune is engaged for shredding services. We collect E-waste and dispose it properly with the help of agency "Kuldeep E-waste disposals".

The college aims to regularly conduct a Green Audit of our college campus to assess our strengths and weaknesses and to further our goals of long-term sustainability. A green audit is a useful tool to determine how and where most energy or water or resources are being used. An Energy Audit is conducted and required to further reduce its carbon footprint. The importance of reducing energy consumption cannot be overstated. The energy audit, with its specialized tools will identify wastage of energy. Such an inspection often reveals several different flaws which cause a loss of significant amounts of energy which the college will not be able to detect.

To create awareness of problems associated with increased use of plastics and to minimise the potential harmful effects of plastic to environment our college has organized Plastic-free Week 2021 in association with Sweden Alumni Network from 18th to 24th October 2021. Activities in this week were an interactive online and offline session to give thought and spread awareness about avoiding the use of "Single Use Plastic".





RJSPM's COP actively coordinates cleanliness activities in the college campus and beyond the campus by organizing different activities like Swachh Bharat Abhiyan, Sawchata hich seva (Cleanliness is service), Swaccha wari-Swasta wari (Clean pilgrimage - healthy pilgrimage) etc. The entry of automobiles inside the campus is restricted to reduce environmental pollution of campus. We encourage our students and staff to use public transportation. Single—use plastic stuffs such as plastic bottles, bags, spoons, straws and cups are banned completely and awareness is created among all teaching, non-teaching staff and students. The NSS and SDO team of our college conducts various programs of cleaning the campus. Landscaping initiatives are best methods to build awareness around the environment. The landscape of trees and plants provide the students and staff with clean and cool air and a soothing environment. We conduct tree plantation activities through NSS team.

We have Medicinal plant garden with well-planned and classified cultivation of medicinal plants. Garden has more than 50 species of medicinally important plants. These plants are particularly used by students for their understanding of practical and theory concepts. Institute has installed sanitary napkin vending and disposal machine, which helps in instant disposal of used napkins in a very scientific and hygienic way without generating harmful emissions. The Municipal Corporation's water supply and bore well are the sources of water supply to the college campus. Our college is aware about the water conservation measures and problems associated with water shortage and therefore we follow the practices for water conservation and efficient use of available water. Water tanks are constructed in campus for proper storage of water. Water is pumped into storage tanks located at different places in the campus. Overhead storage tanks are also available. The water is distributed through pipe network in college campus. Maintenance of water bodies and distribution system is periodically carried out to avoid the loss of water by leakage. Some of the common solid wastes include daily garbage comprising of white used papers, card sheets and materials, rubber waste,

A green audit is a useful tool to determine how and where most energy or water or resources are being used. An Energy Audit is conducted and required to further reduce its carbon footprint. The importance of reducing energy consumption cannot be overstated. The energy audit, with its specialized tools will identify wastage of energy. Such an inspection often reveals several different flaws which cause a loss of significant amounts of energy which the college will not be able to detect.





RJSPM's College of Pharmacy has Organised Plastic-free Week 2021 in association with Sweden Alumni Network India Maharashtra & Goa chapter from 18 October to 24 October 2021. Activities in this week was an interactive online and offline session to give a thought, spread awareness, and bring change in habits towards plastic usage as well as to avoid the use of single use plastics.

Plastic waste is now so ubiquitous in the natural environment that scientists have even suggested it could serve as a geological indicator of the anthropogenic era.

So that, our college in association with Sweden Alumni Network India Maharashtra & Goa chapter decided to celebrate Plastic Free Week 2021 by a series of various programs and events which helped us to minimize the single use of plastics. It provided resources and ideas to help all to reduce single-use plastic waste every day at home, work and college in day today activities.

Need of Awareness Programmes to Avoid the Use of Single Use Plastics

- From 1950s to 70s, only small amount of plastic was produced, so plastic waste was relatively manageable. By the 1990s, plastic waste generation had more than tripled in two decades, following a similar rise in plastic production. In early 2000s, our output of plastic waste raised more in single decade than it had in the previous 40 years. Today we produce about 300 million tons of plastic waste every year. That's nearly equivalent to the weight of entire human population.
- Researchers estimate that more than 8.3 billion tons of plastic has been produced since the early 1950s. About 60% of that plastic has ended up in either a landfill or the natural environment.
- More than 99% of plastics are produced from chemicals derived from oil, natural gas and coal — all of which are dirty, non-renewable resources. If current trends continue, by 2050 the plastic industry could account for 20% of the world's total oil consumption. These single-use plastic products are everywhere. For many of us, they've become integral to our daily lives.
- We need to slow the flow of plastic at its source, but we also need to improve the way we manage our plastic waste. Because right now, a lot of it ends up in the environment.
- Only 9% of all plastic waste ever produced has been recycled. About 12% has been incinerated, while the rest 79% has accumulated in landfills, dumps or the natural environment. Drink bottles, bottle caps, food wrappers, grocery bags, drink lids, straws and stirrers were the next most common items. Many of us use these products every day, without even thinking about where they might end up.
- Rivers carry plastic waste from deep inland to the sea, making them major contributors to ocean pollution. Most plastic items never fully disappear; they just get smaller and smaller. Many of these tiny plastic particles are swallowed by farm animals or fish that mistake them for food, and thus can find their way onto our dinner plates. They've also been found in a majority of the world's tap water.
- By clogging sewers and providing breeding grounds for mosquitoes and pests, plastic waste especially plastic bags can increase the transmission of vector-borne diseases like malaria.







Swachh Bharat Abhiyan (Clean India Mission) is a campaign by the Government of India to clean the streets, roads and infrastructure of the country's 4,041 statutory cities and towns. The activity was organized with reference to NSS circular of Savitribai Phule Pune University, Pune. Principal Dr. Ramesh Katedeshmukh, RJSPM's College of Pharmacy, Dudulgaon, Pune, Vice Principal Mr. Amol Kumbhar, RJSPM's College of Pharmacy, Dudulgaon, Pune and Principal, Prof. R. B. Chintamani RJSPM's Institute of Pharmacy, Dudulgaon, Pune guided the students for this event. Total twenty five number of NSS volunteers and sixteen students of RJSPMIOP involved in this event. On the Sunday, 23rd June 2019 by morning 8.00 am staff and students arrived at Savitribai Phule Pune University, Pune ground.

The Savitribai Phule Pune University (SPPU) Sunday attempted to create a Guinness World record by distributing 16,631 saplings of neem to volunteers of the National Service Scheme (NSS), linked to more than 350 colleges. The saplings are likely to be planted along the Pune-Pandharpur pilgrimage route taken by warkaris during Ashadhi Wari, said university officials.

With the record attempt, the SPPU announced the start of its 'Green Wari' initiative, which combines ecological awareness with the larger objective of promoting conservation of water resources and regenerating the tree cover.

It was a part of socially relevant project 'Nirmal (Clean), Harit (Green) and Swastha (Healthy) wari', as part of the annual pilgrimage to Pandharpur, famously known as 'Ashadhi Wari'.

Chief Minister Devendra Fadnavis, Pune Guardian Minister Chandrakant Patil, Mayor Mukta Tilak, District Collector Naval Kishore Ram and SSPU Vice Chancellor Nitin Karmalkar, among others, were present at the event. Dr.Prabhakar Desai NSS Chief Co-coordinator, SPPU hosted this event. Prof. Sanjay Chakane declared Guinness World record.

As per the guidelines of the Guinness it was instructed that we should build a venue of the attempt with a confined boundary to make it a restricted area along with the entry and the exit gates. Accordingly the place was closed with five feet high structure of iron railings and white cloth. Fifteen entry gates along with long iron corridors were made for smooth entry of the participants into the ground. On the ground, keeping '50 x 50' grid systems in mind, positions for each and every participant were marked. Beside drone cameras, 36 different cameras were fixed in different places, including four wide angle cameras to cover all the entry corridors," said SPPU Senate member Bageshri Manthalkar.







Swachh Bharat Abhiyan (Clean India Mission) is a campaign by the Government of India to clean the streets, roads and infrastructure of the country's 4,041 statutory cities and towns. It includes ambassadors and activities such as run, national real-time monitoring or spread of updated NGOs practices.

The campaign was officially launched on 2 October 2014 at Rajghat, New Delhi, by Prime Minister Narendra Modi. It is India's largest ever cleanliness drive with 3 million government employees, and especially school and college students from all parts of India, participating in the campaign.

The objectives of Swachh Bharat are to reduce or eliminate open defecation through the construction of individual, cluster and community toilets. The Swachh Bharat mission will also make an initiative of establishing an accountable mechanism of monitoring latrine use. The government is aiming to achieve an Open-Defecation Free (ODF) India by 2 October 2019, the 150th anniversary of the birth of Mahatma Gandhi, by constructing 12 million toilets in rural India, at a projected cost of 1.96 lakh crore (US\$30 billion).

The celebration began with a Cleanliness Drive at 9:30 am. Around 50 NSS volunteers along with few teaching, non teaching staff from all the departments have participated in cleaning of ground processes. In a very systematic manner, all the students got divided in different groups and allotted a separate area like garden and corridors in college campus with sufficient number of dust bins and garbage bags. A neat and clean atmosphere was created within two hours and every corner of the campus ground has been observed as dust garbage free.

The "Shauchalaya Nirman" Awareness Rally began at 11:30 am. The rally was headed by Prof. Ghansham sakhare Nss Program officer. Campus Director Kiran Chaudhari sir guided us about the concept. Principal Prof. A.B. Kumbhar and other teaching staff were present during inauguration of rally.
